Your application to work in Canada has been initially approved by Immigration, Refugees and Citizenship Canada. The **final decision to issue you a work permit and allow you to enter Canada** is made after an examination by an officer in Canada. At that time, an officer will assess **if you still meet the requirements** of the *Immigration and Refugee Protection Act*, its Regulations and any other Canadian legislation.

Documents you must bring with you to get your work permit:

- a valid passport or travel document.
 - o Your work permit won't be valid beyond your passport's expiry date.
- a valid temporary resident (visitor) visa (TRV) or Electronic Travel Authorization (eTA), if required.
 - o Your eTA is valid for multiple visits to Canada, until 有効期限 . Your eTA number is eTA番号 and is linked to the passport you used when you applied to work in Canada. If you obtain a new passport before 有効期限 , you will need to apply for a new eTA by visiting <u>www.canada.ca/eTA</u>.



- United States citizens are not required to obtain an eTA or TRV. However, you must provide proof of your status in the United States on entry to Canada. For this reason, it is strongly recommended that you present a valid United States passport or valid United States Permanent Resident Card on entry to Canada.
- Other supporting documents, such as proof that you meet the requirements of the job.

As you gather your documents, be aware that:

- This letter does not authorize you to enter, remain or work in Canada. A border services officer will make that decision when you arrive in Canada.
- This letter is not a passport or travel document. You will not be allowed to board your flight without your passport, even if you have this letter with you.
- Do not pack these or other valuable papers in your checked luggage. Find out more about which documents you will need to bring with you by visiting: Work permit: Prepare for arrival (<u>https://www.canada.ca/en/immigration-refugees-citizenship/services/</u><u>work-canada/permit/temporary/prepare-arrival.html</u>).

Immigration medical examination: You must have a valid <u>immigration medical examination</u> (IME) <u>(https://www.canada.ca/en/immigration-refugees-citizenship/services/application/</u> <u>medical-police/medical-exams/requirements-temporary-residents.html</u>), if required. Your IME must be <u>valid</u> on the day you arrive at the port of entry or you may be found inadmissible.

Health insurance: Temporary workers are only eligible for public health insurance in some provinces or territories. Make sure that you and any dependants coming with you to Canada have **either** adequate health care insurance or enough money in case you need medical attention.

Know your rights: Please be aware that workers are protected by labour and employment laws. You are entitled to a safe workplace where your health is protected. If you experience abuse in your job in Canada, you may be eligible for an <u>open work permit for vulnerable workers</u>.
