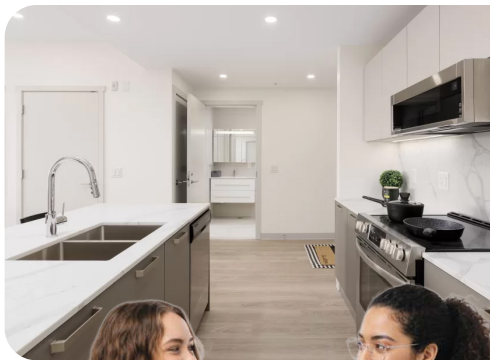

Terms and Conditions

1. Rates are effective for bookings starting from Oct. 23, 2025
2. All prices are listed in Canadian Dollars (CAD \$) and are subject to change without prior notice.
3. Minimum lease term for SSLC Units is 2 weeks and for non-SSLC units is 3 months.
4. GEC's definition of a month is 30 nights.
5. Weekly rates (standard rate) are calculated from the day of the check-in.
6. For monthly rate (incentive rates), a full month rent will be charged for the last month regardless of check-out date of that month.
7. Rates for shared apartments are per bed. Rates for private apartments are per unit.
8. Weekly rates are calculated from Saturday to Saturday or Sunday to Sunday, regardless of weekday check-in or check-out.
9. Rates do not include the Security Deposit, Amenities Fee, or any other applicable fees.

Cancellation Before Check-In	
Notice given more than 60 days before Commencement Date	Placement Fee and Amenities Fee will not be refunded. Deposit and any rent paid will be refunded. Cancellation will be processed with no charge.
Notice given less than 60 days before Commencement Date	Placement Fee, Amenities Fee, and Security Deposit will not be refunded. Any rent paid will be refunded.
Cancellation After Check-In	
<ul style="list-style-type: none"> • A written notice is required. • Subject to a cancellation fee of \$500.00 (a cancellation fee is a charge that is applied when a student decides to cancel their leasing contract before the agreed-upon end date). • Amenities Fee and Security Deposit will not be refunded. • Rent will be required until the last day of the second month after the notice effective start date (the "Notice Period") or the originally agreed end of their lease, whichever is sooner. • If the tenant cancels before the end of the lease, any incentive applied to rent will be adjusted to the amount noted within the lease for the actual length of stay including the Notice Period.
